Minutes of the Ordinary Meeting of Slindon Parish Council
Held at Slindon Coronation Hall, Reynolds Lane, Slindon BN18 0QZ.
On Monday 9<sup>th</sup> January 2023 at 6.30 p.m.

149. Declarations of Interest and Dispensations
Councillor Fenton referenced his role as joint Chair of the Slindon Community Land
Trust.

# 150. Public Participation

Members of the public spoke regarding

- Inconsiderate driving and parking in the parish which included ad hoc blocking of a resident's drive and damage to grass verges. West Sussex County Councillor Trevor Bence raised the possibility of a Traffic Regulation Order to specifically address issues cited in Park Lane and Arun District Councillor Steve McAuliffe, a local byelaw and a scheme whereby verges are adopted by the local community. Where specific issues related to contractors, as in the past, the Parish Council could facilitate a resolution, although an initial discussion and low-key resolution between neighbours where possible was advocated. As proposed by Councillor Bence, there was the potential for the Parish Council to reference consideration for neighbours when responding to planning application as a consultee. Overall, acknowledging the concerns raised, members did not feel that these issues were easily resolved but they would reflect on the suggestions, and their relative merits and practicalities.
- Management of drains, specifically with regards those in Reynolds Lane and expressed thanks to both the Parish Council and Councillor Bence for their support in achieving a resolution. West Sussex County Council had now confirmed work would take place on January 24<sup>th</sup>.
- A wooden handrail on the footpath leading from the Top Field to the A29, identified as being in need of repair and the Chair undertook to assess this.
   Concerns were expressed that crocuses are being mowed before they have died down on the area by the cricket sign on Park Lane.

## 151. Apologies for Absence

Councillors Brimblecombe and Saintas had sent their apologies and It was **Resolved** - to approve their reasons for absence.

# 152. Minutes from the Council Meeting Held On 19<sup>th</sup> December 2022.

It was **Resolved** - to approve the minutes as a true record of the decisions of the meeting and the Chair be authorised to sign them.

## 153. Chair/Councillor Reports

Councillor Rees spoke regarding the May 2023 District and Town/Parish Council Elections and of how best to generate interest amongst residents in joining the Parish Council.

The plight facing Ukrainian refugees to register the use of their vehicles in the UK after 6 months and the associated cost was highlighted, and there is a petition to the Government to extend this period in line with that for other temporary overseas visitors such as students.

## 154. West Sussex County Council (WSCC) Matters

Councillor Trevor Bence spoke regarding the new A27 and of continuing concerns including potential rat-running and of the impact on air quality for those living locally.

## 155. Arun District Council (ADC) Matters

Councillor Steve McAuliffe spoke of the latest A27 Consultation, which ran until 16<sup>th</sup> December 2022, and the District Council's response to be confirmed at its Full Council Meeting 18<sup>th</sup> January 2023.

Councillor Trevor Bence left the meeting.

#### 156. National Trust Matters

Katie Archer, Lead Ranger, had sent her apologies, providing an update on work being undertaken by the team (Annex B).

# 157. Finance Reports

i. Payments and Receipts

It was **Resolved** - to note/approve the listing (Annex A).

ii. Bank Reconciliation at 31.12.2022

It was **Resolved** - to approve the sign off as at 31.12.2022 with the independent quarterly check undertaken by Councillor Fenton.

iii. Budget Monitor at 31.12.2022

Year to date actuals v budget were noted, specifically the additional spend to keep the defibrillator at the Forge in service and emergency purchase of sand bags. Portsmouth Water had agreed to pay the Parish Council compensation in respect of



the burst water main on the A29 in November, equivalent to 50% of the cost of the sandbags. WSCC had been asked to fund the balance, outcome of claim awaited.

## iv. Budget Setting 2023/24

A copy of the approved annual budget had been circulated to all members by email 4<sup>th</sup> January 2023 (Parish Council's Financial Regulations 3.4) and the precept requirement submitted to Arun District Council by email 22<sup>nd</sup> December 2022.

#### v. General Reserves and Earmarked Reserves

The transfers between General and Earmarked Reserves approved at the Council's meeting 19<sup>th</sup> December 2022 had been completed as evidenced on the spreadsheet.

Finance reports to meetings are posted separately to the Parish Council website under the 'Finance and Risk' section.

## 158. Grants and Donations

## i. Funding for the Playground

Arun District Council had now informed the Clerk that Slindon's playground is not an Arun-owned playground and does not therefore fit within their playground strategy for capital works with no capital funding currently available for other playgrounds. There was however an offer to help with the tender specification to obtain best value for money.

There were no further updates on the National Lottery Community Fund application. The previous CIL applications would be withdrawn as there appeared to be no realistic prospect of success, without housing development for the parish itself.

## ii. National Lottery Awards for All

It was **Resolved** – to authorise the Clerk to submit the draft application for seating and towards a new pond island to commemorate the King's Coronation

# iii. South Downs National Park Authority (SDNPA)

The prospect of an information board by the pond was in its very early stages, dependent on funding and possibly via an application to their Sustainable Communities Fund which could provide a maximum of 50% of the cost. A meeting had been arranged at the pond with representatives from the SDNPA and the National Trust had also now expressed an interest in a jointly funded board.

## iv. Operation Watershed

Operation Watershed had now approved the residual spend of £7525. Additional works to be undertaken in the field into which the pond drains at a cost of £7000, supplementing those improvements already made during the first phase of Project ResPOND, and the balance of £525 used towards the replacement pond island, refer minute 159. The preferred contractor to undertake the pond works would be confirmed at the Council's next meeting.

#### 159. Slindon Pond, Church Hill.

#### Pond Island

The total cost of the replacement was estimated at £2350, comprising supply and delivery of two modules and native plants at £900 and estimated installation at £1450. Operation Watershed would contribute £525 (minute 158 iv refers) with the balance hopefully funded through a National Lottery's 'Awards for All' application.



## 160. Governance, Risk and Compliance

i. Website Accessibility Quarterly Checks

Aubergine had confirmed their checks identified no errors or alerts and the Accessibility Statement had been updated.

ii. Payroll Provider

It was **Resolved** to – approve Mulberry & Co's Engagement Letter.

iii. Returns to the Pension Regulator

It was **Resolved** – that these be undertaken by Mulberry & Co, including setting up the NEST account in line with the Clerk's contract.

iv. Annual Playground and Adult Gym Independent Inspections

The annual checks by The Play Inspection Company were imminent, to be undertaken within 8-10 weeks of the order, which was placed on 17<sup>th</sup> October 2022.

v. Risk Assessments

It was **Resolved** – to note, approve and sign off the quarterly reviews of the General and Pond Risk Assessments.

## 161. Clerk's Update

i. Playground and Adult Gym Inspections (routine)

Councillor Thomas had inspected the 'loose' hen rocker handle and made some adjustments to the swing shackles. The Clerk and Chair would undertake a joint check of the equipment on January 16<sup>th</sup> 2023.

ii. Review of the South Downs Local Plan 2022

The pond had been nominated as a Local Green Space, submission dated 28<sup>th</sup> September 2022, update awaited.

iii. Anti-social behaviour

The untaxed vans were no longer in Meadsway and the defaecation in Baycombe Lane had stopped.

iv. Annual Meeting Dates

The Annual Meeting of the Council scheduled to take place on Monday May 15th 2022, provisional hall booking to be confirmed.

The provisional date for the Annual Meeting of the Parish to be confirmed with all Councillors before being announced.

- v. Other Correspondence/Matters Information Only (Received after issue of agenda)
  - ➤ The Parish Council had received an acknowledgement of its Letter of Condolence on the passing of the Queen. This would be archived with sheets from the Book of Condolence at the West Sussex Record Office.
  - An enquiry had been received regarding the possibility of installing a commemorative seat for their loved one in the parish and the Clerk had written to suggest a phone call to discuss this in more detail. More generally, a seat policy might also be considered prudent to cover responsibility for future maintenance as there were a number of seats in the parish.

The cost of ad-hoc gritting requests to 'Sussex Manures' confirmed as £90 +VAT (circular route covering Reynolds Lane, School Hill, Church Hill, Top Road) or £130 VAT (to also include Park Lane) and

ii. A27 Elected Representatives' Forum

The November meeting minutes had now been published on the National Highways website and the date of the next meeting was due in January/February, possibly online.

#### Annex B - National Trust Matters - Minute 156

- 1. Slindon South Lodge gates the work is about to go to tender and we hope to have the new gates in place later in the summer but we have a funding application round to go through with National Highways which involves a lot of forms....
- 2. The winter forestry works should have now begun in Longbeet wood, between Warren Barn and Northwood Farm buildings where Paul and Madeleine Crawley live. Below is a table of all the works planned and attached are maps showing the different locations.

This winter's work is a big job for both the forestry contractor (Coombes) and for us to organise, it has been in the works for the last couple of years. The scale is because it is addressing long linear stretches rather than blocks of woodland and involves arranging power outages and road closures where appropriate. The majority is to address dead and dying Ash trees because of the implications they have for peoples safety. We hope that you understand the necessity of the work.

There are always last-minute changes and adjustments, and we will try and keep you in the loop when we're able via emails and signage. There is no chipping operation planned for any of this work so there won't be the large walking floor chipping machine on site and lots of lorry movements like we had in early 2021. We have also sent this information out via the Slindon Life email circular.

- 3. The winter mowing in Park wood should now be complete, showing off the medieval Park Pale at its best.
- 4. The week beginning 16<sup>th</sup> Jan, a small amount of ash tree removal will take place at Soldiers wood at the Mill Road end. This will be carried out by chainsaw operators with a winch, not with large machinery.
